### **Nomination Guidelines for 2025**

As Women Get On Board's National Strategic Partner, BMO for Women hosts the annual BMO Celebrating Women On Boards program. Each year, BMO for Women and Women Get On Board recognize five outstanding women from across Canada who excel in and out of the boardroom—two from Western Canada, two from Central Canada, and one from Eastern Canada.

To commemorate the 10th anniversary of Women Get On Board in 2025 and celebrate this year's honourees, BMO for Women will host a national five-city tour in the fall. One honouree will be announced at each stop on the tour, beginning with a breakfast celebration in Vancouver on October 7. Register for the event below.

Nominees will be evaluated based on the breadth and depth of their governance leadership as outlined in the guidelines below.

The selection committee welcomes nominations for women who are leading and serving as board members on public and private companies, not-for-profit organizations, and public sector boards.

Each honouree will receive a personalized BMO Celebrating Women on Boards award and a one-year Women Get On Board membership. If the honouree is a current member, they will receive a complimentary one-year extension to their membership. The honouree's membership onboarding or extension will be completed via email.

### **AWARD GUIDELINES:**

Nominees will be evaluated in four key areas.

- **1. Board Leadership:** What board leadership roles has the nominee held (i.e. chair of a committee, chair of the board, etc.) and how have they improved corporate governance in those roles?
- **2. Board Effectiveness:** How has the nominee contributed to board effectiveness for the boards they have served?
- **3. Agent of Change for Board Diversity:** How has the nominee demonstrated their commitment to improving diversity in the boardroom and at the senior management level throughout their board career?
- **4. Volunteer/Community Impact:** How has the nominee demonstrated their commitment to and leadership in their community through the not-for-profit organizations they have served?
